1. 名目値(季節調整系列)について、1980年1-3月期～直近期の原系列に季節調整を行い作成している。なお、季節調整系列は毎回1980年1-3月期まで遡及して改定されることから、最新の速報を利用されたい。
2. 実質値について、名目雇⽤者報酬を家計最終消費支出(除く持ち家の帰属家賃)デフレーターで除して算出した参考値。
3. 名目値について、平成7年(1995年)10-12月期以前の四半期計数は、SNAホームページを参照されたい。

- (2) 「国内需要」「民間需要」「公的需要」「総固定資本形成」の寄与度は、下位内訳項目の寄与度計とは一致しない。
