使用上の注意

1. 季節調整系列について、1994(平成6)年1-3月期～直近期の原系列に季節調整を行い作成している。なお、季節調整系列は毎回1994(平成6)年1-3月期まで遡及して改定されることから、最新の速報を利用されたい。
2. 実質値について、名目雇用者報酬を家計最終消費支出(除く持ち家の帰属家賃及びFISIM)デフレーターで除して算出した参考値。
3. 2006(平成18)年10-12月期以前の計数は、SNAホームページを参照されたい。

V. 寄与度の計算方法について

- (2) 「国内需要」「民間需要」「公的需要」「総固定資本形成」「最終需要」の寄与度は、下位内訳項目の寄与度計とは一致しない。
