## 使用上の注意

- 基礎統計の一つである「毎月勤労統計」(厚生労働省)の500人以上規模事業所の再集計に伴い、雇用者報酬の再推計を行ったため、2004年以降の原系列を2018年10-12月期1次QE公表時に改定した。  
なお、2004年から2011年については暫定的な方法で補間推計を行った。
- 季節調整系列については、1994年1-3月期～直近期の原系列に季節調整を行い作成している。なお、季節調整系列は毎回1994年1-3月期まで遡及して改定されることから、最新の速報を利用されたい。
- 実質値については、名目雇用者報酬を家計最終消費支出(除く持ち家の帰属家賃及びFISIM)デフレーターで除して算出した参考値。
- 2007年10-12月期以前の計数は、SNAホームページを参照されたい。
