## 使用上の注意

- 基礎統計の一つである「毎月勤労統計」(厚生労働省)の500人以上規模事業所の再集計に伴い、雇用者報酬の再推計を行ったため、2004年以降の原系列を2018年10-12月期1次QE公表時に改定した。  
なお、2004年から2011年については暫定的な方法で補間推計を行った。
- 季節調整系列については、1994年1-3月期～直近期の原系列に季節調整を行い作成している。なお、季節調整系列は毎回1994年1-3月期まで遡り改定されることから、最新の速報を利用されたい。
- 実質値については、名目雇用者報酬を家計最終消費支出(除く持ち家の帰属家賃及びFISIM)デフレーターで除して算出した参考値。
- 2007年10-12月期以前の計数は、SNAホームページを参照されたい。

・ 寄与度の計算方法について

実質 GDP 成長率に対する各内訳項目（項目  $i$ ）の寄与度計算は、以下のように行っている。

$p_{i,t}$  :  $t$  暦年の下位項目デフレーター,  $q_{i,t}^{(k)}$  :  $t$  暦年(第  $k$  四半期)の下位項目数量指数,  $T$  :  $T$  年度( $t$  暦年第 2 四半期 ~  $t+1$  暦年第 1 四半期)

(1) 暦年計数（前年比）

$$\% \Delta_{i,(t-1) \rightarrow t} = 100 \cdot \frac{p_{i,t-1} q_{i,t-1}}{\sum_i p_{i,t-1} q_{i,t-1}} \cdot \left( \frac{q_{i,t}}{q_{i,t-1}} - 1 \right)$$

(2) 四半期計数（前期比）

$$\% \Delta_{i,(k-1) \rightarrow k} = 100 \cdot \frac{p_{i,t-1} q_i^{k-1}}{\sum_i p_{i,t-1} q_i^{k-1}} \cdot \left( \frac{q_i^k}{q_i^{k-1}} - 1 \right)$$

寄与度の合計とベンチマーク（比例デントン法）後の増加率の開差は比例的に配分している。

年率寄与度は、前期比寄与度の 4 倍をベースとし、その合計と GDP 成長率（年率）との開差は比例的に配分している。

(3) 四半期計数（前年同期比）

寄与度の合計と増加率の開差は比例的に配分している。

(4) 年度計数（前年度比）

$$\% \Delta_{i,(T-1) \rightarrow T} = 100 \cdot \frac{p_{i,T-1} q_{i,T-1}}{\sum_i p_{i,T-1} q_{i,T-1}} \cdot \left( \frac{q_{i,T}}{q_{i,T-1}} - 1 \right) \quad (\text{近似式})$$

ただし、 $p_{i,T-1} = \frac{p_{i,t-1} \sum_{k=2}^4 Q_{i,t}^k + \frac{\sum_i p_{i,t-1} q_{i,t}^4}{\sum_i p_{i,t} q_{i,t}^4} \cdot p_{i,t} Q_{i,t+1}^1}{\sum_{k=2}^4 Q_{i,t}^k + \frac{\sum_i p_{i,t-1} q_{i,t}^4}{\sum_i p_{i,t} q_{i,t}^4} \cdot Q_{i,t+1}^1}$ （ $i$  が在庫の場合、 $Q$  には在庫残高を用いる）

寄与度の合計と増加率の開差は比例的に配分している。

留意点

- (1) 「純輸出」については、寄与度の符号が前期差の符号と逆になることがあり得る（純輸出実質額は「輸出 - 輸入」の実質額の単純引き算により求められているため）。この場合、寄与度の与える符号が正しいものである。
- (2) 「国内需要」「民間需要」「公的需要」「総固定資本形成」「最終需要」の寄与度は、下位内訳項目の寄与度計とは一致しない。
